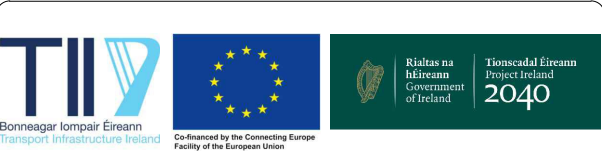

- NOTES ON FENCING:**
- Silt fencing shall be set-back from the SAC boundary to leave a width of riparian habitat undisturbed and protect the SAC and to demarcate the limits of the working area.
 - Temporary hardstanding access tracks with working platforms will be provided from the mainline haulage route to the bridge construction works area on each side of the river to facilitate the piling process and bridge foundation and pier construction. These elements shall be maintained throughout the construction stage.
 - On the southern side of the River Finn hardstand areas will be surrounded by silt fencing and temporary cut off drains around the work platform areas with check dams installed, Surface runoff from the works areas will be directed towards the permanent attenuation pond (No. 10 see General Arrangement Drawing EIA Drawing 4.1)
 - On the northern side of River Finn, where the floodplain presents greater risk, the hardstanding / work platform areas will be replaced by reno-mattresses (or similar) laid directly on the existing ground. The reno-mattresses will provide better protection to the adjacent SAC and River Finn during any periods of flooding.
